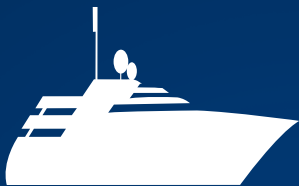

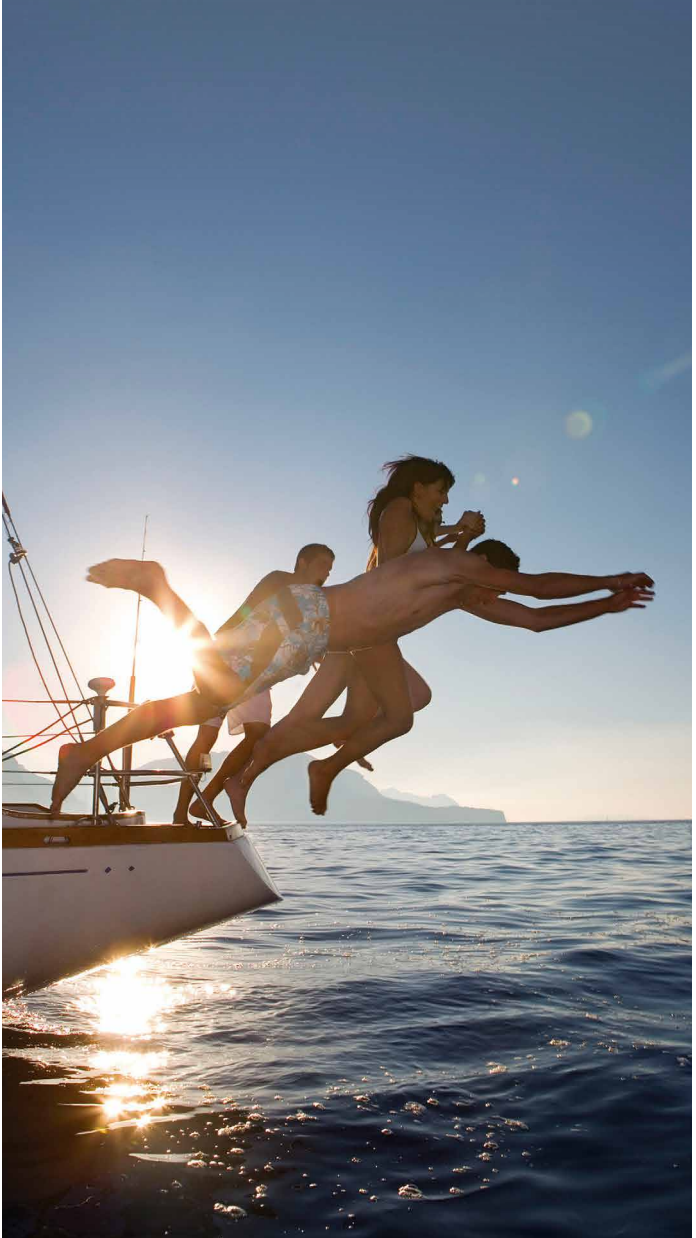
About us

Deductible free claims

The deductible is not applied to a wide variety of Hull claims, or to any Third Party liability claims, to salvage and wreck removal or to towing and assistance and other benefits.



New for Old

Our New for Old deduction is only applied to materials and parts – never to labour costs, nor to basic hull and deck structures. This deduction can be removed by a small increase in premium.



Breakdown assistance & emergency accommodation

An amount is available (depending on the value of your yacht) for emergency towing and assistance or emergency accommodation costs.



Wear and Tear & Latent Defects

If you have a claim under your policy for loss caused by wear and tear, latent defect or electrolysis, only the faulty part is excluded.



Liability cover for everyone

The Pantaenius policy covers your legal liabilities for property damage, death and injury, including the liabilities of your crew.



Skipper Liability

Your Third Party Liability policy is 'portable'; covering your legal liabilities when skippering a borrowed or chartered vessel. (Does not apply if the policyholder is a company, club or similar.)



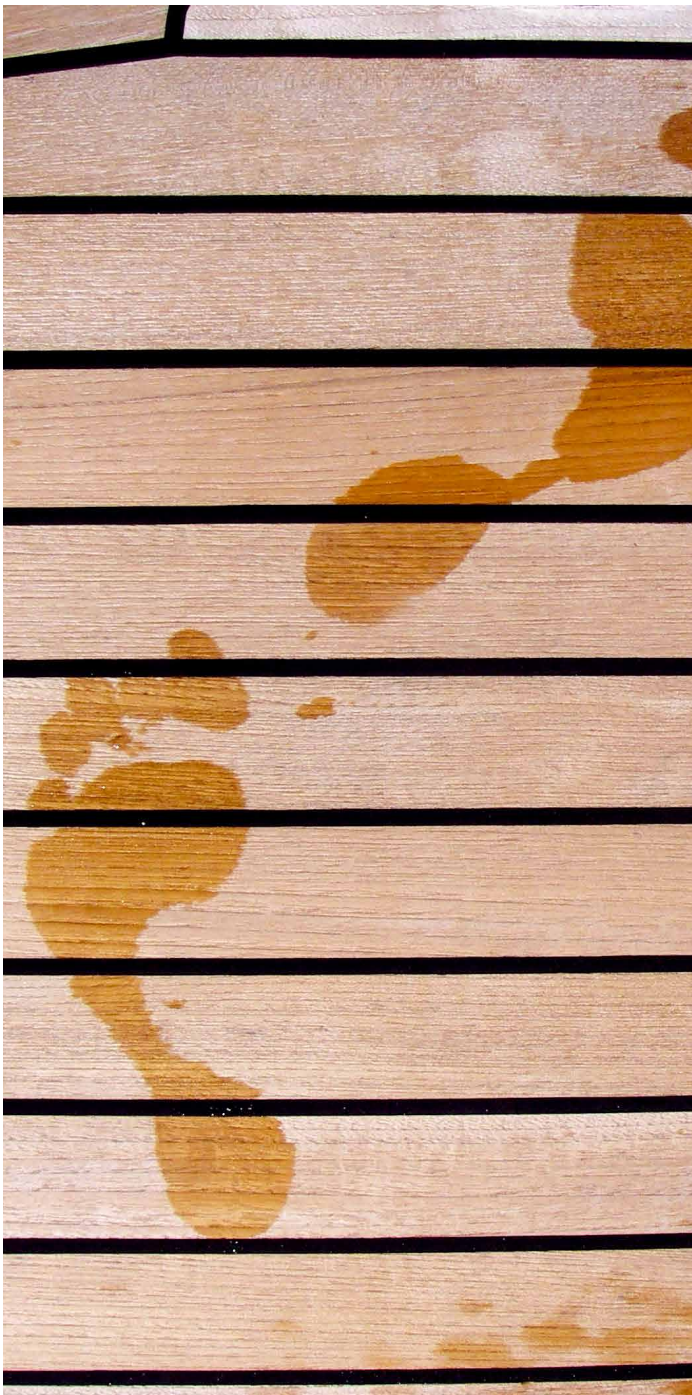
Watersports (including diving)

Your legal liability towards those engaged in watersports from your yacht is covered, and also their and your liability towards anyone in the water!



Water pollution

Your legal liability for water pollution and environmental damage is covered under your Pantaenius policy.

Personal Accident from less than £23

The Yacht Personal Accident policy provides a lump sum in the event of death or permanent disability, a contribution towards medical and repatriation expenses and other benefits following a boating accident. It's easy, inexpensive and even covers accidents that happen during short trips ashore, or if the yacht you are using is one you have chartered.

Legal Expenses

Up to £100,000 is available to cover your legal fees in pursuing those who have caused your injury or damage to your yacht, or to resolve contract disputes relating to your yacht, including the purchase of parts, servicing or repairs plus some attractive little 'extras'. Premiums start at just £10.

Travel Insurance

For holidays, whether or not you are using your yacht as a base and for sailing rallies and longer trips. This policy is designed for UK policyholders and can be arranged either to cover a single trip or multiple trips throughout the year. Apply on-line via our website.

International Healthcare plan for the long term yachtsman

Pantaenius, together with Allianz Worldwide Care, has developed a Medical Expenses Insurance for long term sailing. The policy operates worldwide and provides medical treatment in the event of an accident or illness abroad. Benefits include inpatient and outpatient treatment and emergency dental care.

Crew Policies

If you are employing paid crew then we can arrange the following crew covers: Crew Personal Accident; Crew Medical Expenses; and Employers' Liability Insurance.

What to do next

- 1 Check the details on the Proposal Form are correct, completing as necessary. If you need to make any changes contact us as soon as possible (*see important information below*).
- 2 If it is necessary to alter the terms and conditions previously indicated, as a result of any new information we receive, we will contact you before proceeding with your application for insurance.
- 3 Sign and date the form – not forgetting to fill in the date you require your policy to start – and return it to us.
- 4 Refer to the **Ways to Pay** leaflet and make your premium payment prior to the start date using one of the methods detailed in the leaflet.
- 5 If you wish to pay by direct debit (from a UK Bank account), please return the direct debit mandate with the proposal form.
- 6 Your policy schedule(s) will be issued once your payment has been received. If you would like to receive your policy schedules electronically, please let us know (you can still get a hard copy later if you need to!).
